SUBJECT: NFIP iService Company Regional and Field Support Update

The iService Regional Support Team is responsible for conducting regional activities in support of the National Flood Insurance Program (NFIP).

The principal goals of the iService Regional Support Team are to support their respective FEMA regions by performing outreach activities (presentations, conferences, public open houses, and map meetings); providing research to congressional inquiries for regional stakeholders; responding to declared disasters; and answering inquiries from stakeholders (public, community officials, insurance agents, lenders, adjusters, engineers).

Responsibilities of the iService Regional Support Team include:

- Responding to stakeholder inquiries
- Providing flood insurance technical assistance to FEMA Regional Offices
- Supporting FEMA regions at multiple workshops, meetings, and conferences
- Responding to "Ask the Expert" inquiries
- Performing pre- and post-flood activities
