SUBJECT: Adjusted Dates of Loss – 0421
Hurricane Ida – AL, LA, MS, TN, CT, DE, DC, KY, MD, MA, NJ, NY, OH, PA, RI, VA, WV, ME, NH, VT

Hurricane Ida produced torrential rain, storm surge, and widespread flood damage in the states of Alabama, Louisiana, Mississippi, Tennessee, Connecticut, Delaware, District of Columbia, Kentucky, Maryland, Massachusetts, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Virginia, West Virginia, Maine, New Hampshire, and Vermont. In NFIP Clearinghouse Bulletins W-21010 and W-21014, the Federal Emergency Management Agency (FEMA) assigned EDNs to track the claims arising from this event. FEMA has now adjusted the Dates of Loss for the event as shown below:
